SDGs Where our Software Applications Help

365 Architechs develop software solutions for many of our clients.

Some of these solutions assist those organisations to work towards the sustainable development goals and we are proud to play our part in working with these businesses and non-profit organisations.

One in every six Australian young people are living in poverty².

Where this occurs, a cycle of disadvantage can begin, with poorer educational outcomes and difficulty getting a job following, leading to poorer overall life outcomes and resulting in low income families to start the process again.

We work with many charities who provide services to support people living below the poverty line.

Our CARE application has been developed to assist these organisations by providing a client management and case management system to record the details of individuals assisted and the services provided.

This software currently tracks over 500,000 people and 1,000,000 instances of care.



Climate shocks, conflict and COVID-19 are some of the biggest threats to the global food system.

In Australia, the main groups of people requiring handouts of food are families living on a low income, the unemployed, single-parent families, the homeless and people with mental illness³.

The global pandemic has seen the casual workforce and international students added to this list.

Our CARE application, introduced in SDG 1, is also used to record details of requests for food and the fulfilment of those requests. It enables call centres to triage incoming calls and allocate volunteers to assist those in need.

Some of the charities we work with, provide food hampers during Christmas to support families with challenging circumstances. We are committed to the on-going development of solutions to support those who stand up and tackle food insecurity and its effects on people in Australia.

3 GOOD HEALTH AND WELL-BEING

The global pandemic has seen a sudden and dramatic shift towards videoconferencing and online learning management systems, and 365 Architechs have been quick to respond to with remote working and collaboration systems to many organisations. We also offer online training in all our solutions.

8 DECENT WORK AND ECONOMIC GROWTH



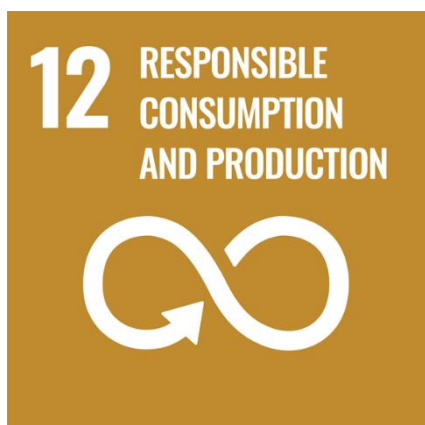
365 Architechs promote sustained, inclusive and sustainable economic growth, full and productive employment and decent work for all.
